Course Description

"Religion Studies" course is one of the compulsory subjects of general education cycle. It is an independent and complete course.

Course aim

The course aims to give objective information about: the origin of religion and free-thinking, history of dogmatic foundations, their functions and values in all spheres of society. Formation through familiarity with the works of famous religious scholars, skills of religious doctrines critical analysis, specific activities of religious organizations and their representatives.

Course objectives

- The study of the history and current state of the main religious traditions, their doctrinal, ritual and ceremonial and organizational features, social interaction between each other, the surrounding society and the authorities;
- Analysis of multilateral and realistic background of religion formation development;
- To develop students' skills in developing their own position in the discussion of various aspects of religious dogma, actual issues of interfaith relations;
- To develop tolerance and interfaith dialogue in students.

As a result of the course studying, students must:

know:

- Significant and common features of major world religions, differences in baseline principles between science and religion, particular creeds and cults of major national and world religions, peculiarities of religious view and man's place in it, moral norms enshrined in the religions of the world. The main categories of religious studies related to issues of freedom of conscience and religious tolerance, the basic tenets of various religious systems, theoretical positions of various religious concepts, the current state of the religious system. Constitutional and legal bases of Kazakhstan state policy concerning the scope of religion.

be able to:

navigate in mainstream denominations, world and Kazakhstan legislation in the field of religion, practically use the knowledge and skills obtained during the study course, to understand the content of religious traditions, to understand their worldview and social and moral value, to apply this knowledge in practice in scientific, Pedagogical and general cultural research spheres, freely navigate the multi-faith environment and differentiate on the religious denominations and religious dogmatic grounds.
